- Honor Sportif USA Clothing's MAP pricing policies as stated here: Sportif USA Clothing advises each of its dealers, distributors, retailers and resellers that advertising Sportif USA Clothing products at a price of 15% or more below the manufacturer suggested retail price as listed or published by Sportif USA Clothing in its most recent suggested retail price list may lead to certain actions, including the discontinuance of its business relationship with such dealer, distributor, retailer or reseller. For the purpose of this policy, the term "advertising" shall include any price listing accessible to consumers directly via the Internet. Sportif USA Clothing's intention and policy is not to engage any dealer, distributor or retailer that advertises Sportif USA Clothing products at prices below MSRP. Sportif USA Clothing supports closeout periods each year beginning on or about July 15<sup>th</sup> for the Spring season and on or about November 15<sup>th</sup> for Fall. During closeout periods, products from the preceding season can be offered at the dealer, distributor or retailer's discretion.
- Use Sportif USA's most current logos, copyright information, photography, and graphics.
- Remove all expired or outdated images as requested by Sportif.
- Display only those styles that are in the Retailer's inventory.
- Not sell or advertise Sportif products on auction sites.
- Only sell Sportif products to end-users.
- Remain in good credit standing.
